President's Remarks

We had a productive spring setting up this summer's projects. Please review the list below and note any areas that you might be interested in assisting us and feel free to contact the coordinator of that project for additional information. All of our directors and project coordinators are volunteers and we can always use help.

FAA Grant Assurance Compliance Issues. We did have sufficient votes at the January meeting to approve the MLAA match to the CDoT Grant for the "Compliance Plan" and we have a contract with Jviation to develop this document. The Board met with Jviation in April for a "kick-off" session and the Advisory Committee met with Jviation, CDoT/Aero and the FAA/ADO (Airport District Office) in May to establish expectations. The project is well underway and should be completed this fall. Preliminary observations have already been developed and will be presented to the Advisory Group later this month. A special meeting will be held with the MLAA membership this fall to review the results. In the meantime, there has also been progress in the national "Through-the-Fence" controversy and a new FAA HQs policy regarding **Residential Thru-The-Fence (RTFF)** was published in the Federal Register on March 18th. A "snap-shot" of our current status is required this month and an "Airport Access Plan" will be required prior to any grant application next year.

Based Aircraft Inventory. We continue to update the aircraft population of Meadow Lake Airport and currently have 378 aircraft listed in the data base and an additional 23 aircraft on a "DNR" (Do Not Report) list. Incidentally, we were contacted on four occasions last year by emergency services and/or search & rescue organizations and this list was a valuable asset in helping us coordinate urgently needed information. A "based aircraft census" is conducted yearly with your dues assessment and we request that all members and users of Meadow Lake airport list and annually confirm any and all aircraft based from their Meadow Lake property. I have to certify this list annually and will be contacting most members over the coming month to verify "N" numbers that our records indicate are based from your property.. If you have not already provided "N" numbers for your aircraft and/or tenants, please contact any Board member with that information. We also need "joint" use info, i.e.: that the aircraft is also sometimes based at another airport.

ASSOCIATION UPDATE

FINANCES

Overdue Assessments: The primary revenue source for MLAA to operate and maintain the airport remains to be annual dues that are assessed against all properties listed on Exhibit "A" of the Bylaws. Enforcement of this obligation has been somewhat sporadic in the past, so the Board has passed Rule 11-01 (enclosure 1) to establish a standard for expectations. We have filed liens on two properties that have failed to pay prior year's dues, and have prepared "Notices of Suspension" for the seven members still delinquent in forwarding their 2011 assessments. These notices will be posted in mid-July, after this newsletter (with encl 1) is published.

Grants. By now most of you know that the AWOS is online and has been commissioned! As we previously reported, AWOSs have a four letter identifier and Meadow Lake's identifier has been changed to **kFLY**. Our active **FAA AIP (Airport Improvement Program) GA Entitlement Grants** include:

- AIP-17/18 (FY'09) - \$150K: \$6,611 land reimburse, \$149,983 for AWOS received (grant complete)
- AIP-19 (FY'10) - \$150K: \$110,831 final land reimburse (revised application under development), AWOS overages (included above), audit of the 2001-2011 land procurement program (pending)
- FY'11 - \$150K ... unassigned and is being held in reserve

Our active **Colorado Discretionary Aviation Grants** include:

- 2008 - \$100,000: for development of the Strategic Business Plan (grant complete)
- 2009 - \$163,273: matching funds for FAA grants, pavement maintenance and re-striping, land reimburse.
- 2010 - \$115,870: additional matching funds and paving (Runway 15 run-up area) (in progress)
- 2011 - \$100,000: for development of the "Compliance Plan", pavement maintenance (in progress)

BYLAWS

May's Annual Membership Meeting resulted in the passing of three significant bylaw revisions for the Association and the changes are attached at enclosure (2) for insertion into your copy of the MLAA Bylaws.

Land Acquisition ... MLAA Project #XX-01

[with multiple FAA AIP and CDOT grants]

- *coordinator*: Dave Elliott, *consultant*: Airport Development Group.
- *cost* (to date): \$5,436,563 [FAA: \$5,008,188 CDOT: \$311,710 MLAA (land match): \$368,332]
- Project began in 2001 with the "Hangar-Restaurant" purchase and evolved into a program to purchase available land surrounding the runway complex to provide a "buffer" with neighboring development. Total MLAA-owned property now exceeds 753 acres. We have received guidance from the Denver ADO for our final reimbursement, and payback of the Colorado SIB loan should be completed by the end of the year (original terms require payback by 2014) **project completion in progress**

Strategic Business Plan ... MLAA Project #08-03

Taxiway Alpha Signage ... MLAA Project #09-09

- *cost:* \$4,725 (signs were donated by EW Systems)
- To install signs along “Alpha” for the access taxiways (“C”, “D”, “E”, “F”) ... signs were purchased by Jamie Johnston (along with the “business signs”). Additional signage, indicating the “Airport Operations Area” have been procured and installed **project complete**

MLA Compliance Plan ... MLAA Project #10-03

- This project was approved by the membership at the January Special Meeting and work has begun. An Advisory Committee (Lee Wolford, Dave Bennett & Bill Clothier) has been formed to work with Dave Elliott and Jviation. “Kickoff” meetings were held with our Board in April 19th and with CDoT and FAA/ADO on May 20th. Jviation (Alan Weichmann) has begun the “snap shot” review of the current airport layout and operation. **project in progress**

Turf Runway/Operation Area ... MLAA Project #10-08

- Due to the HFSC relocation and the increase in winch operations, HFSC has identified and mowed a new “turf landing strip”, approximately where a west-side taxiway for the “new” runway would be. An FAA 7480 is under review by the ADO and Jviation has been contacted to coordinate update to the MLA Airport Layout Plan. Several additional parties have expressed interest in using this area. A new access to the airport and this “op-area” has been constructed off Falcon Highway and a perimeter access road has been developed along the west boundary (adjacent to Falcon Heights). Since this area will be noted on the ALP and listed in the facilities directory, an environmental assessment is required and has been initiated. **project in progress**

MLA Re-enumeration ... MLAA Project #11-02

- Over the years, numerous parties (including fire, police, emergency response, mail & package delivery) have commented on the lack of coordinated enumeration of property address on Meadow Lake Airport. Current numbering is “generally” even numbers to the west side of Cessna Drive and odd numbers to the east, but there are many exceptions and since most properties are numbered from Cessna, whether or not they abut Cessna, confusion remains. A project has been contemplated for some time to develop and propose to El Paso County a “standard” for identifying property addresses on the airport. **project continues to be deferred pending time & resources**

- The Board is working with Jviation to construct a plan to develop the Westside “Bravo” taxiway to improve public access and utility of the MLA O&M building. CDoT/Aero has agreed to allow us to use leftover funds from our 2010 grant to begin the project and carry over the rest into 2012. The total project has five components: (a) construct a “B-2” intersection off the main runway (opposite A-2); (b) widen and overlay “Bravo” from the north end (B-1) to the Johnston taxiway at the south; (c) improve and overlay the ramp in front of the SRE (Snow Removal Equipment) Storage building, (d) construct a run-up area at the north end (opposite B-1), and (e) construct a transient parking area. *in progress*

Residential Thru-The-Fence (RTTF) Certification ... MLAA Project #11-12

- We have received a letter from the FAA Denver Airports District Office relaying the new FAA interim policy regarding residential thru-the-fence access to airports receiving Federal Airport Improvement Program (AIP) grants. A certification of residential lots having access to the airport is required and before we apply for any grants beginning in FY 2013, we must submit an airport access plan. This program is part of the Compliance Plan currently under development by Jviation. *in progress*

The spring soaring season for High Flights was pretty well blown out this year. The high afternoon winds kept us grounded most weekends. However, it is looking like the weather may be returning to more normal patterns, so we are looking forward to good summer and fall soaring.

High Flights continues to work with the MLAA Board to get FAA approval for the Turf Runway on the south west portion of the airport. High Flights developed and submitted to the MLAA Board the "Meadow Lake Airport Glider Operations Procedures". MLAA BoD has adopted this document to provide guidance to anyone on how gliders are to operate at Meadow Lake and how those operations are coordinated with overall airport operations. The procedures have been reviewed by the FAA and deemed sufficient to allow operations at Meadow Lake from our parallel runways with less than standard separation. High Flights added a Youth Membership category this year to allow us to encourage youth involvement in aviation and make it easier for them to get flight instruction. A Youth member pays half dues and has no initiation fee. If they fly each month, then their monthly dues are only \$19. They can remain Youth Members until the age of 23. Our first Youth member and the one person who did fly in the wind was Benjamin Bookman. Benjamin passed his check ride to receive his Private Pilots License with the winds gusting to 25 kts. Congratulations to Benjamin. Sam Tschappler has recently joined High Flights to pursue his Private Pilots License. Benjamin and Sam are a students with the Aviation Education Foundation of Colorado as well. High Flights has 3 additional youth members bringing our total to 5.

HYDROWINCH - SOARING EAGLES FOUNDATION

Hydrowinch is up and running! After several years of design and testing, Hydrowinch is fully operational. At the beginning of May, two partners from Holland, Marco Brombacher and Vincent Geesing, joined Randy Rothe and Eric Deylius who are testing the winch at Meadow Lake airport near Colorado Springs. After a week of extensively testing and tweaking hardware and software in various wind conditions, the winch is performing flawlessly. Hydrowinch was also instrumental, along with High Flights Soaring Club, in providing the

manpower to mow and level the new turf runway at Meadow Lake. They invite you to come out and check out the world's most advanced glider winch.

With Hydrowinch, two seat gliders can be launched to altitudes of 2000 ft AGL in 35-40 seconds with a high degree of safety for about \$15 per launch, using about a liter (one quart) of diesel fuel.

The Soaring Eagle Foundation was formed in the Spring of 2011 with the mission of providing wounded warriors the opportunity to learn to soar. The founding members are two USAF veterans (Jenny Rothe, a former enlisted woman, and Randy Rothe, a retired AF pilot and current United Airlines B757 Captain) and Stewart McQuillan (a paraplegic former Royal Air Force member who is currently a glider pilot and holds the distinction of being the world's first paraplegic helicopter pilot). We intend to base operations on the new turf runway at Meadow Lake, building our infrastructure this year with the goal of starting training of disabled veterans during the summer of 2012.
